1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Client Connection online*, on August 28, 2015.

The *Government of Albania* has received<sup>1</sup> a loan from the International Bank for Reconstruction and Development<sup>2</sup> towards the cost of *Citizen Centric Service Delivery Project* and intends to apply part of the funds to cover eligible payments under the Contract for “*Refurbishing and furniture of the Integrated Citizen Service Center of Kombinat*”, Ref: AL-8521/CW/NCB/2.01.03. Bidding is open to all bidders from eligible source countries as defined in the *Guidelines: Procurement under IBRD Loans and IDA Credits*<sup>3</sup>.

3. The Agency for Delivery of Integrated Services in Albania (ADISA) invites sealed bids from eligible bidders for Refurbishing and furniture of the Integrated Citizen Service Center of Kombinat. The main objective is the fulfillment of all required spaces, while achieving functional performance, fulfilling according norms and standards, finishing treatment, and required humidity, flow of light, ventilation and air-conditioning. The detailed project consists in the refurbishment/ reconstruction of the selected premise and its adaptation into a center for the provision of public services through the establishment and management of receiving counters for the citizens (front office) and integrated public service centers (one stop shop).
