Under the Innovative Good Governance priority, launched in April 2014, the Program "Innovation against Corruption: Building a Citizen Centric Service Delivery Model in Albania" entails a multi-layered reform that focuses on key administrative central government public services to reduce the time and burden for citizens and businesses and improve service delivery quality, transparency and efficiency by using innovative solutions and ICT. As part of the reform, in October 2014, ADISA, the Agency for the Delivery of Integrated Services in Albania, was established to manage the centralized public service delivery to the citizens. - Able to work in a team, handle multiple complex tasks concurrently, prioritize tasks and meet tight deadlines;
- Command of Albanian and English language (spoken and written) is essential.
